# **Transportation Service**

Effective September 1, 2012, Shares, Inc. was approved for a new transportation service available to individuals enrolled in Community Integration and Habilitation (CIH) Waiver. Depending upon the needs of the participant, there are three levels of transportation.

**Level 1:** Transportation via vehicle that is not specially equipped.

**Level 2:** Transportation in a vehicle specially designed to accommodate wheelchairs.

**Level 3:** Transportation in a vehicle specially designed to accommodate a participant who for medical reasons must remain prone during transportation.

Shares, Inc. is certified to provide all levels of transportation under CIH Waiver. There is an annual cap under each level of transportation.

Transportation has not changed for the Family Support Waiver (formerly Support Services Waiver) and continues as before.

## CLIFF'S NOTES

### REPORT FROM YMUR EXECUTIVE DIRECTOR

2012 has come to a close and much has been done to establish Shares in new areas that provide continued programs and services to adults with disabilities.

As the number of participants in our program grows, so does the need to increase the volume of work. Several methods that we will use to grow business in 2013, as highlighted in our new Business Plan, developed by our Sales Department and Management team are:



We signed contracts to produce glow plugs for both E3 and Champion in 2012. In 2013, we should be producing Champion's entire glow plug line which is estimated at 200,000 - 250,000 glow plugs worth roughly \$600,000 - \$750,000.

#### **WIRE HARNESSES**

We are now involving participants in the assembly of wire harnesses and bolt assemblies for AirDog installation kits. This program has not only given new opportunities for participants in the program but also provides a cost savings for WAP, LLC.

#### **FIRST AID KITS**

The kitting we do for outside first aid supply kits is slowly progressing to take over more of the work for an Indianapolis based establishment that has been impressed with our past track record.

#### **WORLD MEDIA GROUP**

World Media Group is a business solutions company, focused on manufacturing high quality optical discs, custom printed USB drives, plastic card printing, full color printing, media packaging and direct-to-customer fulfillment.

WMG is going to outsource their assembly and fulfillment division and if we are awarded these projects. Shares would have consistent work for a large portion of our work force.

2013 should see a steady increase of new jobs, revenue

The goal is to reduce the dependence on Ryobi and Tuff Torg business that was 94% of SFS revenue in previous years.

#### **GLASS FOR GOOD**

The Glass for Good website is complete along with a printed piece to distribute to potential customers.

We are currently developing packaging materials for the glass that should be designed and ready for print by the end of November. ASG Glass (distributor) has agreed to drop ship to alleviate the need for Shares to warehouse materials until our customer base is developed.

Strategic Materials (parent company of ASG Glass) is in the process of installing three new furnaces at their Indianapolis facility to produce the glass for Shares.

Our target customers will be regional retail chains in industries that include; pet supplies, floral, wedding, decorative, and outdoor products.

#### **SUMMER TRIP**


Educational trips at Shares, Inc. continue to be one of the highlights for our participants. We create these vacation trips with fun for all in mind, but also as a learning experience.

# YMUR SOCIAL SERVICES

#### **Money Talks!!**

Don't forget to file your tax return in order to claim the benefits you earned this year! You may be eligible for the **Earned Income Tax Credit (EITC)**.

To qualify for the EITC, you must meet the following rules:

- You must have earned income (less than \$13,660 or \$18,740 if married and filing jointly)
- You cannot qualify as a dependent of another person
- You must be between the ages of 25 and 64 by the end of the year
- Have children under 19, a student can be under 24, or a child who is disabled can be any age

The Earned Income Tax Credit refund will not count as income toward your SSI, Medicaid, Food Stamps, cash assistance, or public housing. However, some of these programs may have a limit on how long you can keep your refund in your bank account.

To learn if you are eligible for the EITC, please visit www. irs.gov and search for EITC.

#### Free Tax Help!!

Why pay to have your taxes done when you can have them done for free? If you earned under \$49,000 in 2012 you can get free tax help. Call 1-800-906-9887 to find the nearest Volunteer Income Tax Assistance (VITA) site near you.

#### 2013 Important Social Security Changes

- All Social Security and Supplemental Security Income (SSI) beneficiaries will receive a 1.7 percent Cost of Living Adjustment (COLA) for 2013.
- Substantial Gainful Activity (SGA) for 2013 is \$1040/mo if you are non-blind and \$1740 per month if you are blind.
- The Trial Work Period Amount for 2013 is now \$750/mo.
- The SSI Federal Payment Standard increased to \$710/mo for an individual and \$1066/mo for a couple.
- The Social Security Administration allows people to attempt to return to work and still collect their benefits. Please feel free to contact a Social Service Department member for further information on how these changes and incentives can benefit you.





The Association of Indiana Solid Waste Management Districts (AISWMD) recently recognized Shares Shredding and Recycling for their outstanding environmental stewardship in regard to their Electronics Waste program.

Each year the AISWMD recognizes organizations that have gone above and beyond in their development of solid waste and recycling related programming and projects and Shares Shredding & Recycling won the Non-profit /Contractor category.

In 2010, Shares Shredding & Recycling added the collection of electronic waste to our operations and we are a registered recycler through the Indiana Department of Environmental Management's Electronics program (IDEM).

Our workers disassemble, sort and sell the materials from electronics for recycling, and assist solid waste districts, business, schools and others in responsible management of electronics. We've collected 43 tons of electronics in 2011 and serve over 150 customers.
