Alex's manager, Tom McMahan, states that Alex is a joy to work with because of his positive attitude and hard work. He always has a smile on his face and unlimited energy.



YMUR LIVING SKILLS LEND A HELPING HAND

The wheelchair helper program is an exciting new program that has started in Shelbyville and Greenfield. There were 17 participants in Greenfield and 17 participants in Shelbyville who have signed up for the program, participated in the training, and successfully completed a competency assessment. The participants demonstrated competency in the following areas:

- Proper pushing technique
- Avoiding obstacles when pushing a wheelchair
- Guiding a wheelchair downhill (simulated)
- Pushing a wheelchair through a doorway that pushes open
- Pushing a wheelchair through a doorway that pulls open

The participants who passed the assessment were given an official certificate of completion and a laminated license to push wheelchairs in the facility and community. The training and assessment will occur annually. If there are participants who would like to sign up next year for the wheelchair helper program, please see Laura Fano in Greenfield or Allison Hackman in Shelbyville.

YMUR SOCIAL SERVICES

Change, Change, and More Change! Effective September 1, 2012 the following changes went into effect for people on a Medicaid Waiver Program:

Support Services Waiver

- The name changed to Family Supports Waiver
- This will be the entry point for everyone to receive waiver services
- Anyone who is currently on a waiting list for any of the waivers, will now be targeted for the Family Supports Waiver
- Case Management was added as a Waiver service
- Families can now choose a Case Manager from four different companies

- The budget cap was increased from \$13,500 to \$16,250 per year
- There is more flexibility on how budgets can be used
- Participant Assistance and Care is a new service option for people who are living on their own or with their families
- For a completed list of the services offered under this waiver, visit www.arcind.org

Developmental Disability Waiver

- The name changed to Community Integration and Habilitation Waiver (CIH)
- The CIH Waiver is now a "Needs Based" Waiver for individuals who meet a specific criteria
- Case Management was added as a service

Autism Waiver

- The Autism Waiver ended August 31, 2012
- These individuals were transferred to the Community Integration and Habilitation Waiver effective September 1, 2012
